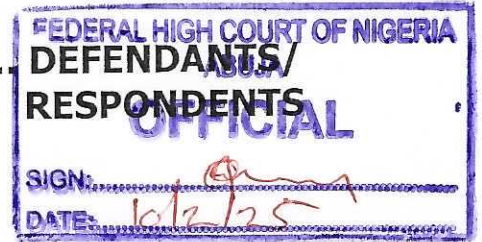

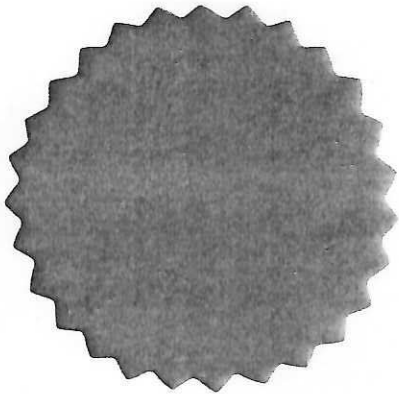


**ORDER**

**AND AFTER HEARING** M. L. Anthony, Esq. of Counsel for Prosecution move in terms of the Motion paper.


**AND** the Court having granted the application.


